3. Executive Summary

- The LRCTC maintained its NHSCSP Accreditation with full approval granted on 22 March 2017, following an accreditation visit on 29th September 2016.
- The staffing structure of LRCTC underwent a reorganisation and a new structure was successfully formed with the establishment of new permanent posts. ("The centre has gone through significant staff changes in the last nine months but this has been a smooth transition and it is evident that there are good team dynamics")*
- **34** courses were run.
 - 4 pre-registration courses (including 2 tuition days)
 - o 8 post-registration courses
 - o 5 non-gynaecological courses
 - o 2 medical laboratory support staff courses
 - 7 medical courses (including ST1 course, Medics/Advanced Practitioner one day update and pathologists gynae and non-gynae courses)
 - 8 sample taker courses
- A total of **345** persons attended courses in 2016/17 (328 persons in 2015/16)
- The evaluation scores (0-5) for all courses which derive from anonymous student feedback ranged from 4.3 to 5.0 which is regarded as "highly relevant" for working practice.
- The LRCTC User Group for NHS London service providers have given excellent feedback and input into the roll out of courses and future development over the year.
- The LRCTC has maintained its good working relationship with NHS London and London SQAS.
- An E-learning module for sample takers has been running in collaboration with IT provider On-click at <u>http://shop.onclick.co.uk</u>
- The NHSCSP require all newly diagnosed cases of cervical cancer to be reviewed as part of the Invasive Cervical Cancer Audit. Qualifying cases are sent to a local UK Cytology Training Centre for an external review. LRCTC reviewed 89 cases from four regions.

4. Introduction

The London Regional Cytology Training Centre, hosted at North West London Hospitals NHS Trust, was originally founded in 1979; it has a national and international profile for high-quality cervical and non-cervical / diagnostic cytopathology training. Due to the current demand for a wide range of cancer screening training for many healthcare professional groups, we have diversified into other training activities which make maximum use of our expertise and facilities to meet this demand for other healthcare professional groups.

5. Pre-registration Programmes

This year, in keeping with the on-going national downward trend, we are training fewer non-medical trainees. The C&G Diploma course was discontinued in 2016. Consequently the requirement for the training of C&G assessors from individual laboratories has been discontinued. However, this has now been replaced by targeted training for assessors with trainees participating in the NHSCSP Training in Cervical Cytology

i) Introductory course

This is a four week intensive course, attended within the first 6 months of employment, and after students has spent a minimum of 6 weeks in the home laboratory. Two courses were run on 3rd October 2016 and 30 January 2017 with a total of 3 students.

ii) Follow-up Course

This is a one week course attended by students in their second year, designed to reenforce cytological principles outlined in the introductory course. No courses were held but two courses are scheduled for 2017.

iii) Pre-exam course

This is a one week revision course focusing on examination technique to candidates sitting their NHSCSP Training in Cervical Cytology final exam. No courses were held but one has been scheduled for August 2017.

iv) Monthly Tuition Days

The LRCTC runs monthly "tuition days" for trainees to supplement and enhance the introductory and follow-up courses. This is a single day whereby trainees attend for topic-related workshops. It also allows the LRCTC staff to maintain their contact with trainees and improve monitoring of students' progress.

Two tuition days were held with 2 individual students attending.

v) Host Laboratory Visits

After completion of the Introductory Course, a written report is prepared and a member of staff from the LRCTC visits the trainee's laboratory to present the report to the trainee, training assessor, and laboratory manager. The meeting is designed as a positive feedback mechanism and enables all parties to discuss and sign up to a formal individual training plan whilst discussing the requirements for the portfolio and assignments that will have to be carried out within the department. Following the Introductory Course, two host laboratory visits were made.

vi) Training Officer/ Provider Meeting

Training officer/NHSCSP assessor meetings and User meetings are held each year to gain feedback from laboratories on our courses and service requirements as well as to keep them updated and disseminate information on current issues. The meetings were held conjointly on the 20th September 2016 and were well attended with 13 attendees.

This is part of our annual review and adds to the data required for the NHS London Performance Indicator Contract. All outcome results are fed back electronically after they have been issued and discussed at the NHS London Annual General Review

vii) Examination Centre for the NHSCSP Training in Cervical Cytology

This centre is one of the national examination venues for NHSCSP Training in Cervical Cytology. This underscores the high quality facilities and the excellent reputation of the LRCTC staff who administer the examinations. However, this year, due to lack of applicants, the examination was not held at the LRCTC.

viii) LBC Conversion Course

There is low demand for LBC conversion courses for participants wishing to acquire the skills to be able to screen cervical samples utilising the ThinPrep method of slide preparation. One course was held on 20 March 2017 with 1 student attending.

ix) Introductory Course for Medical Laboratory Assistants

In response to the increasingly formalised training of laboratory support staff, the LRCTC have introduced a one day introductory course for MLA staff. Two MLA courses were run on 25 April 2016 and 16 November 2016 with 12 students attending.

6. Qualified Staff CPD Programmes

i) Update Courses for BMS/Cytoscreeners

It is a mandatory requirement that all Cytoscreener and BMS staff screening cervical cytology under the auspices of the NHSCSP undergo an update course every three years.

The LRCTC ran eight three-day update courses on 20-22 April 2016, 17-19 May 2016, 6-8 June 2016, 6-8 September 2016, 22-24 November 2016, 7-9 December 2016, 17-19 January 2016 and 27-29 March 2016. A total of 113 Cytoscreeners and BMSs attended.

This modular three day update course is regularly re-populated with current topic related slides and in addition completely re-vamped every three years at the start of each new Update cycle. The new cycle began in 2017 with the first course held on 17th January 2017.

ii) NHSCSP Assessors Training in Cervical Screening

Assessor training was incorporated into the Host Laboratory visits. One laboratory based training session was held at Kettering on 25th November 2016.

iii) External Quality Assurance Programme for Cervical Cytology (EQA)

The LRCTC is host to representatives from London Regional QARC to assess slides for inclusion in the mandatory regional EQA programmes. Due to centralisation of the regional EQA programmes, the LRCTC facilities have not been required. However, an expression of interest has been made for the facilities to be used in future rounds.

iv) Technical External Quality Assurance (TEQA)

Due to centralisation of the regional EQA programmes, the LRCTC facilities have not been required. However, an expression of interest has been made for the facilities too be used in future rounds.

v) Pathologists Course

The LRCTC, since its inception in 1979, has run a Pathologists course aimed primarily at trainee pathologists about to sit their MRCPath examination. This is a highly successful five day course covering gynaecological and non-gynaecological cytopathology. Due to the changes in the Royal College of Pathologists training syllabus, the pathologist's course now comprises of two parts; a one week nongynaecological cytology course with optional exam component and a three day gynaecological course with an optional exam component.

The non-gynaecological courses ran on 12-16 September 2016 and 13-17 March 2017 with a total of 28 attendees.

The three day gynaecological cytology course was run on 1-3 March 2017 but as expected the attendance was low with 4 attendees, reflecting the fact that very few trainees wish to pursue gynaecological cytology in their careers.

vi) Medical Specialist Trainees course (ST1)

The LRCTC runs a five day basic gynaecological cytology course for London Regional ST1's, which is contracted by the London Deanery as part of their specialist pathology training.

Two courses ran on 31 October - 4 November and 7-11 November 2016 with a total of 21 attendees.

vii) One Day Gynae Update for Consultants and AP staff:

A one day update for consultant pathologists and advanced practitioner biomedical scientists has run since 2008, and aims to maintain their continued professional development in cervical cytology.

Two courses were run on the 20 May 2016 and 28 September 2016 with a total of 14 attendees.

7. Additional Courses Developed in Partnership with NHS London

i) Non-gynaecological training for BMS staff

The LRCTC has enhanced its non-gynaecological cytology training portfolio for BMS staff to support the introduction of the IBMS Diploma in Expert Practice in Non-Gynaecologic Cytology. The training school offers modules in urinary, respiratory and serous fluid cytology in order to support BMS staff as part of CPD and career progression.

Two respiratory cytology courses were held on the 13-14 June 2016 and 22-23 March 2017; two urinary cytology courses were held on 7-8 July 2016 and 29-30 November 2016 and one serous cytology course was held on 22-23 September 2016. The courses were attended by a total of 44 attendees.

ii) Cervical Sample Takers Foundation Courses

This is a two day theoretical introductory course run by LRCTC to enable suitably qualified nurses and doctors to be trained in cervical sample taking, coupled with a practical portfolio whereby trainees have to take a minimum number of adequate smears. After successful completion of all parts of the portfolio, they gain certification. Four courses were run on 4&8 April 2016, 4&6 May 2016, 11&12 July 2016 and 14&18 November 2016 with a total of 57 attendees.

iii) Cervical Smear Sample Takers Update Courses

This course is to enable all clinical staff taking cervical smears to maintain their certification by regular triennial updates as part of their continuing professional development and best practice. Four courses were run on 5 April 2016, 3 June 2016, 19 September 2016 and 16 January 2017 with a total of 44 attendees.

iv) NHS Service Provider Meeting

As part of our Performance Indicator Contract, the London NHS Service Providers group met with QCPM NHS London to discuss annual reports and confirm action plans and agree training course requirements and employer's needs on 24 November 2016.

v) Distance Learning

The LRCTC has a dedicated website (<u>www.lrctc.org.uk</u>) which includes educational packages for CPD and distance learning.

LRCTC has developed, in partnership with the e-learning provider On Click, an on-line course for sample taker training updates. The course content includes changes to the NHS CSP such as HPV testing, sample handling policies as well as topics suggested by sample takers themselves such as female genital mutilation and updated on a 6 monthly cycle.

On Click continues to be a well subscribed on-line training resource for sample takers and is currently offered as an additional resource to participants attending the sample taker update courses.



8. Course Feedback Evaluation Scores

Evaluation forms are given to all course participants and completion of the forms is actively encouraged. All feedback is anonymous and each course topic is rated from 1 to 5 together with any pertinent comments. From this data, an average course score is calculated and the results are displayed in the chart below.

All courses held in 2016/17 were rated as "highly relevant" to student's needs and work place requirements. The average score for all courses was in excess of four out of five.

9. Invasive Cervical Cancer Audit

All newly diagnosed cases of cervical cancer require a local review to be undertaken.

In certain circumstances where cervical cytology has been performed, there is a requirement for the cytology to undergo an external review at a local UK Cytology Training Centre.

- All slides taken during the two years prior to diagnosis that were originally reported as negative or inadequate, irrespective of the review diagnosis.
- All slides reported as negative or inadequate that were subsequently upgraded at local review to moderate dyskaryosis or worse, irrespective of when they were taken.
- Any slides originally reported as showing borderline change or mild dyskaryosis that were subsequently upgraded at local review to severe dyskaryosis, glandular neoplasia, or invasive carcinoma.

LRCTC receives external review cases from four regions: London, East of England, East Midlands and East Sussex. In addition, it receives cases from South West Regional Cytology Training Centre based at Bristol.

LRCTC received 89 cases from four regions totalling 114 slides.

The majority of cases submitted were squamous cell carcinomas (49), followed by a significant number of adenocarcinomas (38). There was just one case of adenosquamous carcinoma and one case where no histology outcome was given.

The LRCTC consensus opinion agreed with the local review in 67 cases (75%). Of the remaining 22 cases, 18 were downgraded and 4 cases were upgraded. Findings are stored on a database located on the LRCTC shared server.

10. Accreditation

An assessment team visited LRCTC under the NHS Cervical Screening Programme Assessment Scheme on 29th September 2016. Following the visit, a report was approved on 12 October 2016. LRCTC received positive feedback concerning the facilities, course and course materials, team dynamics, support from Health Education England and the slide bank. It also noted the positive feedback from course participants.

Three non-compliances were noted

- 1. Documents illustrating the communication structure did not describe the lines of responsibility and accountability clearly
- 2. Frequency of formal training centre business meetings and training officer network meetings did not meet required standards
- 3. Not all documentation for CPD, EQA and appraisals was available.

An action plan addressing the "minor" non-compliances was drawn up and a response made to the NHSCSP.

Full accreditation was granted and a certificate of approval was issued by the NHSCSP on 17th March 2017 and endorsed by the Clinical Professional Group for Cervical Screening Education and Training (Appendix 4)

11. Additional Activities

LRCTC has a library of gynaecological and diagnostic cytology cases together with workshop sets. These slides are available on request to clinical and scientific staff for review in supporting clinical staff in their pre-exam preparations and for educational purposes. Microscopes are booked in the departmental diary on an ad hoc basis during times when the department is not running any courses. Requests for this purpose amounted to an additional 36 days of LRCTC facilities usage.

The LRCTC rooms and facilities are used by other Trust departments especially the multiheaded microscope which is utilised for pathologist training meetings.

A review of facilities and equipment was also undertaken which resulted in the addition of new camera software and hardware updates

Quality and Commissioning Summary of Performance

Overall

Northwick Park Hospital is commended on having achieved a Green RAG rating in 2015-16, a continuation of excellent results and Green ratings and 100% percentile performance ratings for the past 5 years. This excellent result was reflected in the robust systems processes evidenced in both the QCPM submissions and the additional information arising at the assurance meeting.

Qualitative

Quantitative
